THIS MATTER came on for consideration without a hearing on the *Expedited* Motion For Authority To Conduct Rule 2004 Examinations *Duces Tecum* Of The Debtors [Doc. 842] (the "Motion for Examination") filed by Robert E. Tardif, Jr. (the "Trustee"), as Chapter 7 Trustee of the substantively consolidated bankruptcy estates of Ulrich Felix Anton Engler, Private Commercial Office, Inc., and PCO Client Management, Inc. ("Engler," "PCO," and "PCOM," respectively, or collectively, the "Debtors"). The Court, having reviewed the record of this bankruptcy case and being otherwise fully advised in the premises, does hereby

ORDER as follows:

1. The Motion for Examination is GRANTED.

2. The Trustee is authorized to conduct Rule 2004 examinations *duces tecum* of Ulrich Engler, individually and in his capacity as the corporate representative of PCO and PCOM, at the federal penitentiary where Engler is currently incarcerated or such other location mutually agreeable to the Trustee and law enforcement authorities.

3. The Trustee shall coordinate a mutually agreeable date and time for Engler's Rule 2004 examinations with the appropriate law enforcement authorities.

4. The Rule 2004 examination of Engler shall be conducted prior to Engler's extradition or deportation to the Republic of Germany.

5. The scope of the Rule 2004 examinations may include all matters listed in Bankruptcy Rule 2004(b).
