**Proceedings:**

Mr. Kroop advises the court that there has been positive negotiations between the debtor, the City of Glendale and Moyes. There is an agreement in principle to prepare a consensual plan based on the plan already on file. An amended plan and disclosure statement will be filed and all of the other matters on calendar today can be adjourned until after plan confirmation. He discusses the issues with the court.

Mr. Baldiga provides the court with a status report regarding the sale of the team.

Mr. Kroop reminds the court that there are 4 cases that are jointly administered. The plan only covers the Coyotes Hockey LLC case. A motion to convert the remaining 3 cases will be filed since there are no assets or liabilities.

The court notes the hearing on the amended disclosure statement will be held no earlier than 1/10/11. Everything on todays calendar will be continued to the same date & time.
