ORDERED, that the Application be, and hereby is, GRANTED; and it is further

ORDERED, that having satisfied the requirements of sections 328, 330 and 1103 of the Bankruptcy Code and Rule 2014 of the Bankruptcy Rules and all applicable rules of this Court, the Committee is authorized to employ and retain Greenberg Traurig as its attorneys *nunc pro tunc* to November 1, 2012 on the terms set forth in the Application and the Affidavit; and it is further

ORDERED that Greenberg Traurig shall be compensated in accordance with Sections 330 and 331 of the Bankruptcy Code, any applicable Bankruptcy Rules, U.S. Trustee Guidelines and any orders of this Court; and it is further

ORDERED that the Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.
