**ADMINISTRATOR’S WITHDRAWAL OF
OBJECTION TO CLAIMS OF ECOLAB, INC.**

Ronald L. Glass, the Administrator (the “Administrator”) appointed under the confirmed chapter 11 plan (the “Plan”), files this *Withdrawal of Objection to Claims of Ecolab, Inc.* (the “Withdrawal”) as follows:

1. On February 4, 2014, the Debtors filed their Fourteenth Omnibus Objection to Claims Pursuant to Sections 105 and 502(b) of the Bankruptcy Code and Rules 3001, 3003 and 3007 of the Federal Rules of Bankruptcy Procedure [Docket No. 1385] (the “Objection”), by which the Debtors objected to various claims including Claim Nos. 228-1 and 228-2 (the “Claims”) filed by Ecolab, Inc. (“Ecolab”).

2. The Effective Date of the Plan was April 17, 2014 [Docket No. 1536]. Pursuant to Section 8.10 of the Plan, the Administrator is charged with administering the claims reconciliation process.

3. The Administrator hereby withdraws the Objection, but only insofar as it applies to the Claims of Ecolab, without prejudice and reserves all rights to file any objection at any time
