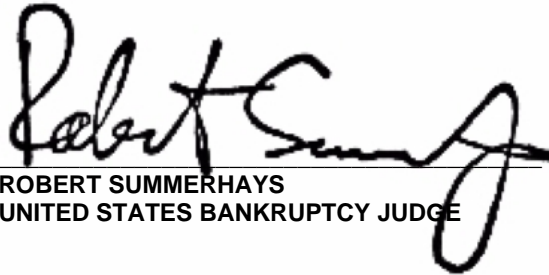

**ORDER GRANTING FIRST INTERIM AND FINAL APPLICATION OF
THE DERBES LAW FIRM, LLC FOR COMPENSATION AND REIMBURSEMENT OF
EXPENSES WITH INCORPORATED MEMORANDUM FOR THE PERIOD
NOVEMBER 1, 2012 THROUGH JUNE 2, 2014**

The Court has before it the First Interim and Final Application of The Derbes Law Firm, LLC for Compensation and Reimbursement of Expenses with Incorporated Memorandum for the Period November 1, 2012 through June 2, 2014 (“the Application”) [P-1556]. This Court has reviewed the Application and the record in these cases and finds that no objection to the Application was filed or served, that good and sufficient notice of the Application was provided, and that there is good cause for granting the Application. Accordingly, it is therefore

ORDERED that the Application is hereby **GRANTED**.

FURTHER ORDERED that, for work performed and services rendered during the time period of November 1, 2012 through June 2, 2014, The Derbes Law Firm, LLC is allowed the payment of compensation as an administrative expense for professional fees as attorney for the Unsecured Creditors Committee in the amount of Nine Thousand Two Hundred Ninety-Three and 75/100 (\$9,293.75) Dollars, and the reimbursement of expenses in the aggregate amount of One Thousand Four Hundred Seventy-Three and 87/100 (\$1,473.87) Dollars, for a total of Ten Thousand Seven Hundred Sixty-Seven and 62/100 (\$10,767.62) Dollars.

FURTHER ORDERED that Debtors are authorized to pay The Derbes Law Firm, LLC Ten Thousand Seven Hundred Sixty-Seven and 62/100 (\$10,767.62) Dollars.
