JUDGMENT

This matter came for trial on March 17, 2011.

PRESENT: JOHN B. PERRY, ESQ., Attorney for Plaintiffs, Cora Ann Ball and Elwyn Ball;

GABRIELE F. THOMPSON, ESQ., Attorney for Defendants, Capital City Cornichon Corp. and American Home Assurance Company.

After receiving the pleadings, evidence, and memoranda, and hearing the argument of counsel, and based upon the Reasons for Judgment issued by this Honorable Court,

IT IS ORDERED, ADJUDGED AND DECREED that there be judgment herein in favor of the plaintiffs, Cora Ann Ball and Elwyn Ball, and against the defendants; Capital City Cornichon Corp. and American Home Assurance Company, finding the defendants 100% liable for this July 26, 2008 accident;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Cora Ann Ball be awarded \$125,000.00 for her mental anguish, pain and suffering, and loss of enjoyment of life, \$99,115.00 for her past medical bills, and \$5,000.00 for her future medical care, for a total of \$229,115.00;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Elwyn Ball be awarded \$15,000.00 for his loss of consortium;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that plaintiffs be awarded legal interest from the date of judicial demand as well as all costs, including the expert fees and deposition costs for those depositions used at trial.




