

IT IS FURTHER ORDERED that the Debtors provide notice of the entry of this Order to (a) the Landlords, the tenant and the non-debtor parties listed on Exhibit 1 to the Motion, (b) the Non-Debtor Parties to the Personal Property Leases listed on Exhibit 2 to the Motion, (c) the Non-Debtor Parties to the Contracts listed on Exhibit 3 to the Motion; (c) the secured creditor, through Atalaya Administrative, LLC, and its counsel of record, Brent R. McIlwain and David F. Waguespack, (d) the thirty largest unsecured creditors, the identity of which may be amended from time to time, (e) the twenty (20) additional random unsecured creditors, (f) all parties who have requested special notice pursuant to Bankruptcy Rule 2002, (f) the Unsecured Creditors Committee, if appointed, or its counsel if one has been retained, and (g) the Office of the United States Trustee.
