AFFIDAVIT OF DISINTERESTEDNESS

BEFORE ME, the undersigned notary public, personally came and appeared

THOMAS J. SOLARI

who, after being duly sworn, did aver and state that:

1. My name is Thomas J. Solari, and I am over the age of 21 and am competent and authorized to make this Affidavit. I am a partner at the law firm of Woodley, Williams Law Firm, L.L.C. (the "Firm").

2. This Affidavit is based on my personal knowledge and my review of Firm records, which I have custody and control over in the course and scope of my practice and which are maintained by the Firm in the course of its regularly conducted legal activities.

3. Of the three debtors, Piccadilly Restaurants, LLC, Piccadilly Food Services, LLC and Piccadilly Investments, LLC (collectively, the "Debtors"), I represent Piccadilly Restaurants, LLC in the lawsuit entitled "Marilyn Williams vs. Piccadilly Restaurants, LLC, Docket no. 243465, 9th Judicial District Court, Parish of Rapides, State of Louisiana.

4. To the best of my knowledge, neither the Firm, nor any of its partners, associates, or staff members are related to any of the Debtors, their creditors, or any other party in interest, or their respective officers, attorneys, or accountants.

5. To the best of my knowledge, neither the Firm, nor any of its partners, associates, or staff members are related to the United State Trustee for the region covering the Western District of Louisiana, or any person employed in the Trustee's office.

6. To the best of my knowledge, neither the Firm, nor any of its partners, associates, or staff members are a creditor of any of the Debtors, **except with regard to legal fees and expenses owed to the Firm by Piccadilly Restaurants, LLC for work performed by the Firm prior to the Notice of Bankruptcy in the defense of Piccadilly Restaurants, LLC in the matter identified in Paragraph 3 of this affidavit, which fees and expenses total \$6,944.52.**

7. To the best of my knowledge, neither the Firm, nor any of its partners, associates, or staff members are an equity security holder, or an insider of any of the Debtors.

8. To the best of my knowledge, neither the Firm, nor any of its partners, associates, or staff members are or were, within 2 years before the date of the filing of the Debtor's bankruptcy petition on September 11, 2012, a director, officer, or employee of any of the Debtors.


