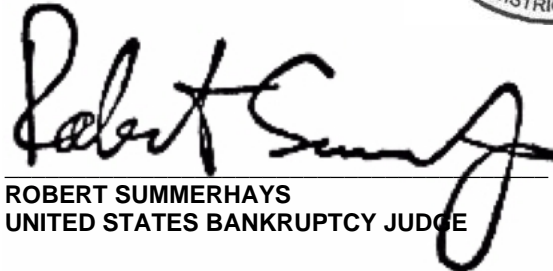

by the Law Firm of Jones, Walker, Waechter, Poitevent, Carrère and Denègre, L.L.P. as Counsel to the Debtors and Debtors-in-Possession (Docket No. 400) (the “Application”) filed by Jones, Walker, Waechter, Poitevent, Carrère and Denègre, L.L.P. (“Jones Walker”).

Considering the Application, the lack of opposition thereto, and the applicable law;

IT IS ORDERED that the Application is GRANTED; and

IT IS FURTHER ORDERED that on account of their representation of the Debtors and Debtors-in-Possession for the time period from September 19, 2012 through October 31, 2012, Jones Walker is allowed compensation in the total amount of \$268,944.00 for a total of 855.1 hours expended, and the reimbursement of expenses in the aggregate amount of \$14,079.55 for a total of \$283,023.55; and

IT IS FURTHER ORDERED that the Debtors are authorized to pay Jones Walker \$53,788.80 in accordance with the terms of the *Order Granting Motion for an Administrative Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals and Committee Members* (Docket No. 231).
