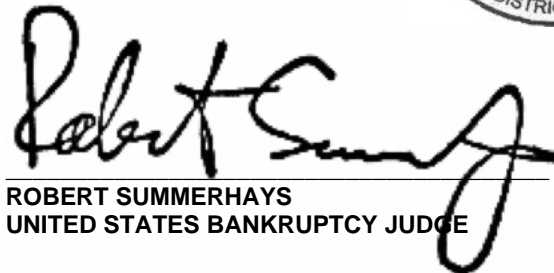

AGREED ORDER

CONSIDERING, the Motion for Adequate Assurance of Payment for Utility Services filed by Cleco, Corp., and the City of Alexandria (P-450) and (P-448); and upon consideration of the agreement of the parties, for the reasons orally assigned:

IT IS ORDERED that within 30 days of the entry of this order, Piccadilly Restaurants, LLC (the “Debtor”) pay to Cleco Corp., \$26,222.00 as a cash deposit for post-petition services pursuant to section 366 of the Bankruptcy Code.

IT IS FURTHER ORDERED that within 30 days of the entry of this order, the Debtor pay to Cleco Corp., \$11,722.64 for pre-petition amounts due pursuant to the terms of the *Final Order Pursuant to Section 366 of the Bankruptcy Code (I) Prohibiting Utility Companies from Altering, Refusing, or Discontinuing Utility Services, (II) Deeming Utility Companies Adequately Assured of Future Performance and (III) Establishing Procedures for Determining Adequate Assurance of Payment* (the “Utility Motion”)(P-109);

IT IS FURTHER ORDERED that within 30 days of the entry of this order, the Debtor pay to the City of Alexandria \$15,000.00 as a cash deposit for post-petition services pursuant to section 366 of the Bankruptcy Code.
