AMENDED NOTICE OF HEARING (Docket #528)

PLEASE TAKE NOTICE that, on March 4, 2013, the above-captioned debtors and debtors-in-possession (collectively, the “Debtors”),² filed a *Second Interim Application For Compensation For The Period Of November 1, 2012 Through As Counsel To The Debtors And Debtors-In-Possession, January 31, 2013, And Reimbursement Of Expenses, By The Law Firm Of Jones, Walker, Waechter, Poitevent, Carrere & Denegre, L.L.P.* (the “Fee Application”) (Docket #528). The amount of the Fee Application is \$261,846.00 for a total of 756.00 hours expended, and reimbursement of expenses in the aggregate amount of \$26,642.54. Pursuant to a previous administrative order of the Bankruptcy Court, 80% of the fees have been paid, and 100% of the expenses have been paid. Therefore, of the total fees of \$261,846.00, Jones Walker seeks payment in the amount of \$52,369.20, or 20% of the fees. PLEASE TAKE FURTHER NOTICE that any and all objections to the Fee Application must be in writing and filed with the Clerk of this Court **no later than seven (7) days before the Hearing**. A copy of the Objection should be sent to counsel for the Debtors at the New Orleans, Louisiana address shown below.
