Pursuant to the *Order Granting Motion of the Debtors and Debtors-in-Possession for an Administrative Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals* [Docket No. 111], the Debtors are now authorized to pay \$52,957.48,² which sum is comprised of (a) \$48,946.00² (representing 80% of \$61,182.50,² the requested fees for the applicable period) and (b) \$4,011.48 (representing 100% of the requested expenses), on an interim basis without further Court order.
