# COMPENSATION STATEMENT OF STILLWATER ADVISORY GROUP LLC [Dkt. # 301]

Stillwater Advisory Group LLC ("Stillwater") hereby submits its first and final Compensation Report pursuant to the Order Authorizing the Debtors to (I) Employ and Retain Stillwater Advisory Group LLC to Provide the Debtors with a Chief Restructuring Officer, and (II) Designate David N. Phelps as Chief Restructuring Officer for the Debtors *Nunc Pro Tunc* to the Petition Date entered December 9, 2014 (Doc. 301) (the "Retention Order")<sup>2</sup> and respectfully states as follows:

1. Pursuant to the Retention Order, the Debtors were authorized to employ and retain Stillwater to provide the Debtors with a Chief Restructuring Officer under the terms of the Engagement Letter, and David N. Phelps was appointed as the Chief Restructuring Officer of the Debtors effective *nunc pro tunc* to the petition date, with such engagement continuing on through November 12, 2014.

- 2. Under the Engagement Letter, Mississippi Phosphates Corporation paid Stillwater a \$100,000 retainer (the "Retainer") to be held as security for all fees and expenses incurred by Stillwater, and Mississippi Phosphates Corporation agreed to indemnify David Phelps, Stillwater and Stillwater's officers, members managers and other "Indemnified Persons" from and against any and all pending or threatened claims, and to pay Stillwater for each Indemnified Person's professional time arising in connection with preparing for or testifying at any deposition, hearings, trials, or other discovery or proceedings in connection with the engagement, all as more fully described in the Engagement Letter.
- 3. Under the Retention Order, Stillwater was directed to file with the Court and serve on the Debtors, the Agent for the Pre-petition Lenders and the DIP Lenders, the United States Trustee for the Southern District of Mississippi a Compensation Report for the time period from the Petition Date through November 12, 2014, and provide for a 21-day objection period.
- 4. Attached hereto as **Exhibit A** is a detailed invoice dated September 20, 2016 (the "Invoice") that describes the services provided by Stillwater, the compensation earned, and itemized expenses incurred. In summary, Stillwater earned compensation in the amount of \$56,270.00 based on approximately 133.4 hours of professional services rendered during the applicable period, and actual out-of-pocket expenses in the amount of \$11,761.04 incidental to the services provided, for a total of \$68,031.04 (the "Amount Due"). The Invoice further reflects the proposed application of the Retainer to the Amount Due, which application will result in a Retainer balance of \$31,968.96 to be held by Stillwater as security for the partially unliquidated indemnification claims.<sup>3</sup>

5. Unless a party receiving notice of this Compensation Statement and entitled to object files an objection within twenty-one (21) days hereof, Stillwater shall promptly apply the Retainer against the Amount Due pursuant to Retention Order.
