To insure proper noticing and in compliance with Federal Rules of Bankruptcy Procedure Rule 4001(a)(1), please serve a copy of your *\*MOTION FOR RELIEF FROM THE AUTOMATIC STAY IMPOSED BY 11 U.S.C. SECTION 362* filed on behalf of Gregory McCloud (Dkt. # 381) and the *Notice of Hearing* (Dkt. # 388 ) to all affected parties and the Twenty Largest Unsecured Creditors (or the Unsecured Creditors' Committee if one has been appointed by the United States Trustee).

The *Twenty Largest Unsecured Creditors* may be obtained via PACER: *Query> Creditor> Creditor Type: 20 Largest Unsecured Creditors*.

If a *Creditors' Committee* has been appointed the members may be obtained via PACER: *Query> Party*.

Mailings must be completed by **January 21, 2015**.

Certificate of Service must be filed with the court on or before **February 5, 2015**.

The Certificate of Service (the "certificate") must specify the method of service, and must identify all parties served. A list containing the names and addresses of the 20 largest unsecured creditors or creditors' committee members (whichever is applicable) may be attached to the certificate. (*Example is shown on the back of this notice*).
