**NOTICE OF DEBTORS' AGREEMENT TO EXTEND THE DEADLINE FOR INVESTIGATION TERMINATION DATE, OBJECTIONS, AND CHALLENGE PERIOD UNDER INTERIM DIP FINANCING ORDER ONLY FOR THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY, AND MISSISSIPPI DEPARTMENT OF ENVIRONMENTAL QUALITY**

PLEASE TAKE NOTICE that Mississippi Phosphates Corporation and each of the affiliated debtors, each as debtor-in-possession (collectively, the "*Debtors*"), with the consent of the United States Environmental Protection Agency, Mississippi Department of Environmental Quality (collectively, the "*Governments*"), the Official Committee of Unsecured Creditors (the "*Committee*"), and the Agent and Pre-Petition Lenders (collectively, the "*Lenders*"), file this *Notice of Debtors' Agreement to Extend the Deadline for Investigation Termination Date, Objections, and Challenge Period under Interim DIP Financing Order only for United States Environmental Protection Agency and Mississippi Department of Environmental Quality* ("*Notice to Extend Challenge Period*") in order to extend the March 16, 2015 Investigation Termination Date and Challenge Period deadline under the *Notice of Debtors' Agreement to*

**NOTICE IS FURTHER GIVEN** that the March 16, 2015 Investigation Termination Date and Challenge Period deadline under the previous *Notice to Extend Challenge Period* is extended until and including **Monday, March 30, 2015, at 5:00 p.m. (central time)** to permit the Governments, **and only those entities, but no others**, to file an adversary proceeding or contested matter (i) challenging or objecting to the validity, perfection, enforceability, or priority of the Agent's and Pre-Petition Lenders' security interests in and liens on the Pre-Petition Collateral or the amount and allowance of the Pre-Petition Indebtedness, or (ii) otherwise asserting any claims or causes of action against the Agent or Pre-Petition Lenders (any action under (i) or (ii), a "**Challenge**").
