ORDER APPROVING STOUT RISIUS ROSS, INC.'S FIFTH AND FINAL APPLICATION FOR ALLOWANCE AND PAYMENT OF FEES AND EXPENSES FOR THE PERIOD AUGUST 26, 2016 THROUGH JANUARY 09, 2018

Upon consideration of Stout Risius Ross, Inc.'s ("SRR") Fifth and Final Application for Allowance and Payment of Fees and Expenses for the Period of August 26, 2016 Through January 09, 2018 (the "Application"),² the Court finds that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334 and the Standing Order of Reference of the U.S. Bankruptcy Court for the Southern District of Texas; (b) this is a core proceeding under 28 U.S.C. § 157(b); (c) venue is proper in this Court under 28 U.S.C. § 1408; (d) the relief sought in the Application is in the best interest of the Debtors, its creditors and all parties-in-interest in the case; (e) the legal and factual bases set forth in the Application establish just cause for the relief granted herein; and (f) adequate notice of the Application has been given, no objections were filed, and no other notice is necessary; and upon all of the proceedings had before this Court and after due deliberation and sufficient cause appearing therefor; it is hereby ORDERED THAT:

- 1. SRR is allowed final compensation of \$243,559.50 for professional services and reimbursement of \$659.87 for expenses rendered on behalf of the Debtor during the four interim application periods from August 26, 2016 through August 31, 2017.
- 2. It is ordered that SRR is awarded fees of \$243,559.50 and reimbursement of \$659.87 for expenses as an administrative expense for the period August 26, 2016 through August 31, 2017.
- 3. SRR is allowed final compensation of \$32,125.00 for professional services rendered on behalf of the Debtor from September 1, through January 09, 2018.

² All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms as set forth in the Application.

- 4. It is ordered that SRR is awarded fees of \$32,125.00 as an administrative expense for the period September 01, 2017 through January 09, 2018.
- 5. The Debtors are authorized and directed to take all other actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Application.
- 6. This Court shall retain jurisdiction with respect to all matters related to the interpretation or implementation of this Order.
