## AFFIDAVIT OF OMAR J. ALANIZ REGARDING OPERATIONAL STATUS OF DEBTOR AND DISBURSEMENTS UNDER 28 U.S.C. § 1930(a)(6)

- 1. My name is Omar J. Alaniz. I am an attorney with Baker Botts L.L.P., counsel for ABC Dentistry, P.A. ("ABC Dentistry").
- 2. I am of legal age and sound mind and am fully competent to make this affidavit. The facts stated within this affidavit are within my personal knowledge, based upon information provided to me by ABC Dentistry, and/or a review of filed court documents.
- 3. As part of its reporting requirements to the United States Trustee, ABC Dentistry filed monthly operating reports covering the months of August 2016 through November 2017. These filings are listed in further detail in **Exhibit A**.
- 4. Following the confirmation of the Debtors' joint Chapter 11 plan of reorganization (the "Plan") on December 13, 2017 [Docket No. 360], ABC Dentistry, under its reporting requirements, filed post-confirmation quarterly operating reports covering three quarters ending in December 2017, March 2018, and June 2018 respectively. These filings are listed in further detail in **Exhibit A.**

5. On June 13, 2018, the Court closed the Debtors' chapter 11 cases [Docket No. 384]. Accordingly, ABC Dentistry ceased filing post-confirmation operating reports.

6. On July 2, 2018, Brewer & Pritchard, P.C., J. Mark Brewer, and A. Blaire Hickman moved to reopen the bankruptcy case to adjudicate a dispute with its former client Dr. Saeed Rohi—a dispute that should not directly impact ABC Dentistry [Docket No. 392]. The Court granted the motion to reopen the case on July 11, 2018 [Docket No. 396].

7. Since the bankruptcy case reopening, ABC Dentistry has made zero disbursements.

Additionally, ABC Dentistry has been a non-operating entity with zero net cash flow with zero cash receipts and disbursements over same period.
