Your claim was scheduled as a disputed, contingent and unliquidated claim. Accordingly, you must file a Proof of Claim if you wish to participate in the cases or share in the Class 7 distribution. All proofs of Claims with respect to Claims arising from the rejection of executory contracts or unexpired leases, if any, must also be filed with the Bankruptcy Court by March 29, 2005. Any Claims arising from the rejection of an executory contract or unexpired lease not filed within such time will be forever barred from assertion against the Debtors or the Reorganized Debtors, their Estates and property unless otherwise ordered by the Bankruptcy Court or provided in the Plan, all such Claims shall, from and after the Effective Date, be subject to the permanent injunction set forth at Article X.I. of the Plan.
