ORDER OF COURT

AT PITTSBURGH, in said District, this _____ day of _____, 2005 upon consideration of the Final Fee Application of Kirkland & Ellis LLP ("K&E") for Final Compensation and Reimbursement of Expenses for the period June 15, 2004 through December 30, 2004, it is hereby Ordered, Adjudged and Decreed that the Final Fee Application of K&E be granted and that they be compensated for their services rendered in the Final Fee Application period as follows:

1. The Court hereby approves 100% of the fees for the period from June 15, 2004 through December 30, 2004, which amount is \$2,395,918.50, of which amount K&E has already received: (i) 100% for the period June 15, 2004 through September 30, 2004 and (ii) 80% for the period October 1, 2004 through November 30, 2004, which amount is \$1,815,040.90. The Court hereby approves payment of 100% of the expenses for the period June 15, 2004 through December 30, 2004, which amount is \$113,057.70, of which K&E has already received 100% for the period June 15, 2004 through November 30, 2004, which amount is \$102,146.33.

2. Further, the Debtor is authorized to pay K&E the balance for the remaining 20% of the approved fees for the period October 1, 2004 through November 30, 2004, which amount is **\$155,237.10**. The Debtor is further authorized to pay K&E 100% of the fees for the month of December, 2004, which amount is **\$425,640.50** and 100% of the expenses for reimbursement which amount is **\$10,911.37**, for a total amount of **\$591,788.97**.
