**ORDER GRANTING, IN PART, DEBTORS' (I) NINTH OMNIBUS

PURSUANT TO 11 U.S.C. § 502(c)(1) AND PLAN ARTICLE VIII(A)(2)**

Upon consideration of the Debtors' (I) Ninth Omnibus Objection to Claims and the (II) Motion to Estimate Such Claims to be \$0.00 for the Purposes of Distribution [CM/ECF#1806, filed on May 10, 2005] (the "Ninth Omnibus Objection"²), and good cause having been shown; and upon proper consideration by the Court, it is hereby

ORDERED that the Claims listed on Exhibit A attached hereto are hereby disallowed and expunged in their entirety; and it is further

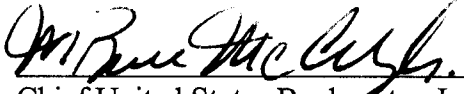
² All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Ninth Omnibus Objection or the Plan.

ORDERED that this Order is entered without prejudice to the rights of the Reorganized Debtors to object in the future to any of the Claims referenced herein, on any other ground not addressed by the Ninth Omnibus Objection.
