ADMINISTRATIVE PROOF OF CLAIM


TO THE HONORABLE MARY F. WALRATH, UNITED STATES BANKRUPTCY JUDGE:

Hartford Fire Insurance Company ("Hartford") hereby asserts it has an original administrative claim in the above-captioned bankruptcy case in the amount of \$168,523.37. In support of its administrative claim, Hartford respectfully represents as follows:

1. On December 8, 2011, ALC Holdings LLC (the "Debtor") filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code.
2. The Debtor continued in possession of its property pursuant to Sections 1107 and 1108 of the Bankruptcy Code.
3. Hartford's administrative claim is based on insurance policy number(s) 84-WE-ZL5251, 84-UEN-NM3637, 84 UUN-KV0972, and 84-XHU-KV1127 covering the periods between 12/08/11-04/01/12, (the "Insurance Policy"). Pursuant to the Insurance Policy, Hartford provided the Debtor with Workers Compensation, General Liability, Package, and Umbrella, insurance coverage during the above-referenced period. A copy of the Statement of Premiums is attached as Exhibit A.
4. Pursuant to the Insurance Policy, all premiums will be determined by Hartford's manuals of rules, rates, rating plans and classifications.
5. Pursuant to Section 507(a)(1) of the Bankruptcy Code, administrative expenses, which include the cost of preserving the estate during the pendency of the bankruptcy proceedings, are given priority status over all other unsecured claims.
6. State laws require the Debtor to maintain workers compensation insurance for the benefit and protection of their employees working. As a result of Hartford insuring the Debtor for the post-petition period, the estate has been preserved and benefited.



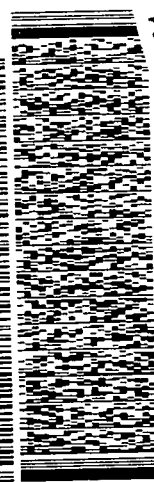
