* Interest continues to accrue on any tax due at a rate determined by G.S. 105-241.21.(a) until paid.


3. That because of the above indebtedness, judgments have been docketed in the Office of the Clerk of Superior Court Division, General Court of Justice of North Carolina as follows:

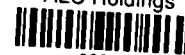
Wherefore; the Division requests that its priority claim be protected, enforced, and paid in accordance with law.

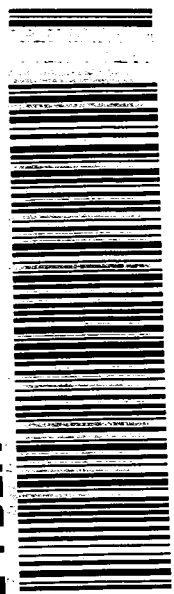
