**ORDER AUTHORIZING AND APPROVING SIXTH
AGREEMENT PURSUANT TO 11 U.S.C. § 1110 FILED UNDER SEAL
REGARDING SEVEN AIRCRAFT AND THEIR RESPECTIVE ENGINES**

This cause comes before the Court on the “Debtors’ Notice Of Sixth 1110 Filing Under Seal Regarding Seven Aircraft And Their Respective Engines” (the “Sixth 1110 Filing”) pertaining to seven (7) aircraft and their respective engines. The Court, having considered the

Sixth 1110 Filing under seal and being duly advised of the premises, finds that good cause exists for granting the relief requested.

IT IS THEREFORE CONSIDERED AND ORDERED that the Sixth 1110 Filing pertaining to seven (7) aircraft and their engines which was filed with the Court under seal, hereby is and shall be approved.

IT IS THEREFORE FURTHER CONSIDERED AND ORDERED that parties that can demonstrate a direct financial interest in such aircraft, such as “owner/participants” or holders of debt instruments pertaining to such aircraft, shall have the right to inspect the Sixth 1110 Filing or adequate protection stipulation affecting their interests, upon entry into a confidentiality agreement with the Debtors. Notwithstanding the foregoing, trustees or indentured trustees thereunder shall be permitted to serve copies of the stipulations to such affected parties, provided that all payment and other key economic terms therein are properly redacted.
