MOTION TO SHORTEN NOTICE ON MOTION TO COMPEL ASSUMPTION OR REJECTION OF UNEXPIRED LEASE OF NONRESIDENTIAL REAL PROPERTY

The Indianapolis Airport Authority (the "IAA"), by and through counsel, for its *Motion to*Shorten Notice on Motion to Compel Assumption or Rejection of Unexpired Lease of NonResidential Real Property (the "Motion"), respectfully states the following:

- 1. On April 21, 2005, the Debtors filed their *Third Motion for Entry of an Order Extending Time to Assume or Reject Unexpired Leases of Nonresidential Real Property on Shortened Notice to and Including the Earlier of May 3, 2005, or the Date on Which a Plan of Reorganization is Confirmed (the "Extension Motion")*, through which the Debtors have sought a third extension of time to assume, assume and assign, or reject leases of nonresidential real property. Pursuant to Notice issued on April 21, 2005, the Debtors' Extension Motion has been set for hearing on May 3, 2005 at 10:30 a.m.
- 2. On April 22, 2005, the IAA filed its Objection to the Debtors' Extension Motion and its *Motion to Compel Assumption or Rejection of Unexpired Lease of Non-Residential Real Property* ("Motion to Compel"). The IAA's Motion to Compel seeks the entry of an Order requiring that the Debtors immediately assume, assume and assign, or reject an unexpired lease of nonresidential real property between the Debtors and the IAA.

- 3. For the reasons set forth herein, the IAA respectfully requests that the Court enter an order shortening notice of the IAA's Motion to Compel and schedule such motion for hearing on May 3, 2005 at 10:30 a.m.
- 4. As more fully set forth in the IAA's Motion to Compel, cause exists to compel the assumption or rejection of the unexpired lease described therein on an immediate basis and it is appropriate to hear the IAA's Motion to Compel on an expedited basis. In addition, the issues set forth in the Motion to Compel are interrelated with the Debtors' Extension Motion and the IAA's Objection thereto, thereby making it most efficient to hear and address such issues contemporaneously. Finally, the IAA anticipates that its Motion to Compel may be contested and, per the *Notice of Additional Omnibus Hearing Dates* submitted in the Debtors' jointly administered proceedings on March 1, 2005, the next available Omnibus Hearing to consider contested matters is June 7, 2005.
- 5. The IAA's request to shorten notice will not unduly prejudice the Debtors and will provide interested parties with a full and fair opportunity to consider and object to the Motion to Compel.

WHEREFORE, the IAA respectfully requests that, pursuant to Bankruptcy Rule 9007, notice of the Motion to Compel be shortened such that the Motion to Compel may be heard on May 3, 2005 at 10:30 a.m., and that this Court grant such other further relief as the Court may deem proper.
