**ORDER GRANTING FOURTH INTERIM AND FINAL APPLICATION OF  
PONADER & ASSOCIATES, LLP FOR  
COMPENSATION AND REIMBURSEMENT OF EXPENSES  
AS CO-COUNSEL FOR THE DEBTORS**

This matter came before the Court on the FOURTH INTERIM AND FINAL APPLICATION OF PONADER & ASSOCIATES, LLP FOR INTERIM COMPENSATION ALLOWANCES AND REIMBURSEMENT OF EXPENSES AS CO-COUNSEL FOR THE DEBTORS (the "Application") filed by Ponader & Associates, LLP (docket #4060). The Court, having reviewed the Application and the supporting Declaration Of Wendy W. Ponader, and being otherwise sufficiently advised, now GRANTS the Application. Accordingly,

IT IS HEREBY ORDERED that the Application is granted in all respects and the Court (i) with respect to the fourth interim application, approves and allows compensation to Ponader

& Associates, LLP for attorneys' fees for the period October 1, 2005 through February 28, 2006 in the amount of \$16,272.50, (ii) authorizes Ponader & Associates, LLP to be paid the outstanding sum of \$3,254.50 from the retainer; (iii) approves, allows and awards to Ponader & Associates, LLP on a final basis those fees and expenses requested in the Prior Applications (as defined in the Application) and requested in the Application for the period October 1, 2005 through February 28, 2006; and (iv) holds that all compensation and reimbursement of expenses previously awarded pursuant to the Prior Applications and the Application are now finally determined.<sup>2</sup> All fees and expenses allowed by this Court are allowed as an administrative expense, given priority.
