**ORDER STAYING ENFORCEMENT OF SECTION 6.5
OF THE ILLINOIS LIQUOR CONTROL ACT**

This matter coming before the Court on the Motion of the debtors and debtors-in-possession in the above-captioned case (collectively, the "Debtors") to stay enforcement of Section 6.5 of the Illinois Liquor Control Act (the "Motion");² the Court having reviewed the Motion; the Court finding that (i) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), (iii) the relief requested in the Motion is in the best interests of the Debtors, their

estates and their creditors; (iv) proper and adequate notice of the Motion and the hearing thereon has been given and that no other or further notice is necessary; and (v) good and sufficient cause exists for the granting of the relief requested in the Motion after having given due deliberation upon the Motion and all of the proceedings had before the Court in connection with the Motion. Therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

1. The Motion is GRANTED.
2. Section 6.5 of the Illinois Liquor Control Act that precludes liquor suppliers from supplying alcoholic beverages to an entity which is more than 30 days in arrears in the payment of the amounts due and owing for prior sales of alcoholic beverages to such entity, is hereby suspended with respect to the Debtors during the pendency of these cases.
3. The Court shall retain jurisdiction over all matters arising from or related to the interpretation or implementation of this Order.
