WITHDRAWAL OF OBJECTION TO CLAIM NUMBERS 1051 AND 1052 FILED BY NORTHWEST AIRLINES, INC. / NOTICE OF SETTLEMENT

Northwest Airlines, Inc. ("Northwest") filed claim number 1052 asserting an unsecured non-priority claim against ATA Airlines, Inc. ("ATA") in the amount of \$220,352.86 and claim number 1051 asserting an unsecured non-priority claim against ATA Holdings Corp. (together with ATA, the "Debtors") in the amount of \$220,352.86 (claim numbers 1052 and 1051 are referred to herein collectively as, the "Claims"). On July 31, 2006, the Debtors filed their Objection to Class 7 Trade Claims and Notice of Response Deadline and Hearing (Docket No. 4323) (the "Objection) objecting to the Claims and various other claims asserted by trade creditors. Accordingly, the Debtors, by counsel, hereby withdraw the Objection solely as it relates to the Claims so that the Claims may be allowed or disallowed as provided above.
