**ORDER GRANTING OBJECTIONS TO CLAIM NUMBERS 1996, 2000, 2003, 2007,
2252 AND 2253 FILED BY THE CITY OF CHICAGO AND THE
CHICAGO DEPARTMENT OF REVENUE**

This matter is before the Court on the Objection of ATA Airlines, Inc. to Certain Claims of the City of Chicago and the Chicago Department of Revenue and Notice of Response Deadline and Hearing filed by ATA on July 26, 2006 (Docket No. 4281) and the Reorganized Debtors' Objection to Claims of the Chicago Department of Revenue and Notice of Response Deadline and Hearing filed by the Reorganized Debtors on July 31, 2006 (Docket No. 4311) (collectively, the "Objections"). Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Objections.

The Court, having considered the Objections and argument presented at any proceedings held before the Court, finds: (i) that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (ii) that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) that due and proper notice of the Objections was given; (iv) that neither the City of Chicago nor the Chicago

Department of Revenue filed a response to the Objections; (v) that Claim Number 2252 was amended and superseded and is survived by Claim Number 2259; (vi) that Claim Number 2253 was amended and superseded and is survived by Claim Number 2258; (vii) that Claim Numbers 1996, 2003 and 2007 were resolved by the Term Sheet and were satisfied; and (viii) that Claim Number 2000, excepting only the portion of such claim for rejection damages arising from rejection of the O'Hare Agreement, was resolved by the Term Sheet and was satisfied. Therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

1. Claim Number 2252 is disallowed in its entirety and expunged.
2. Claim Number 2259 is allowed as an unsecured class 7 claim against the estate of ATA in the amount of \$0.00.
3. Claim Number 2253 is disallowed in its entirety and expunged.
4. Claim Number 2258 is allowed as an unsecured class 7 claim against the estate of ATA in the amount of \$0.00.
5. Claim Numbers 1996, 2003 and 2007 are disallowed in their entirety and expunged.
6. Claim Number 2000 is reduced and allowed as a general unsecured non-priority claim against the estate of ATA in the amount of \$324,578.14. Claim Number 2000 shall be classified as either a class 6 or a class 7 claim once all claims of the City of Chicago have been resolved.
