## ORDER ON OBJECTION TO CLASS 7 TRADE CLAIMS AND NOTICE OF RESPONSE DEADLINE AND HEARING

This matter is before the Court upon the Objection To Class 7 Trade Claims And Notice Of Response Deadline And Hearing (docket #4323) (the "Objection")<sup>2</sup> filed by ATA Airlines, Inc. and ATA Holdings Corp. (collectively, the "Debtors").

On August 4, 2006, the Debtors filed the Notice of Settlement of
 Objection to Class 7 Trade Claims and Notice of Response Deadline and Hearing as it Relates to

ATA Holdings Corp. (04-19866), ATA Airlines, Inc. (04-19868), Ambassadair Travel Club, Inc. (04-19869), ATA Leisure Corp. (04-19870), Amber Travel, Inc. (04-19871), American Trans Air Execujet, Inc. (04-19872), ATA Cargo, Inc. (04-19873), and Chicago Express Airlines, Inc. (04-19874).

Claim Numbers 482 and 2186 filed by Oracle (Docket No. 4373) setting forth the settlement reached between the Debtors and Oracle with respect to claim numbers 482 and 2186.

- 2. On August 8, 2006, the Court entered and order (Docket No. 4422) disallowing and expunging claim number 844 filed by Dublin.
- 3. On September 5, 2006, the Debtors filed the Withdrawal of Objection to Class 7 Trade Claims and Notice of Response Deadline and Hearing (as it Relates to Claim No. 337 only) (Docket No. 4467) withdrawing the Objection solely with respect to claim number 337 filed by NCR.
- 4. On September 29, 2006, the Debtors filed the Withdrawal of Objection to Claim Numbers 1051 and 1052 Filed by Northwest Airlines, Inc./Notice of Settlement (Docket No. 4490) withdrawing the Objection solely with respect to claim numbers 1051 and 1052 filed by Northwest and setting forth the settlement reached between the Debtors and Northwest with respect to those claims.
- 5. On September 29, 2006, the Debtors filed the Withdrawal of Objection to Claim Number 1024 Filed by Marathon Ashland Petroleum LLC/Notice of Settlement (Docket No. 4491) withdrawing the Objection solely with respect to claim number 1024 filed by Marathon and setting forth the settlement reached between the Debtors and Marathon with respect to claim number 1024.

The Court finds that (i) it has jurisdiction over the matters raised in the Objection pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) the relief requested in the Objection is in the best interests of the Debtors, their estates and their creditors; (iv) proper and adequate notice of the Objection and the hearing thereon has been given and that no further notice is necessary; and (v) good and sufficient cause 4519723 1.DOC

exists for the granting of the relief provided herein after having given due deliberation upon the Objection and all of the proceedings had before the Court in connection with the Objection.

Therefore, IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

- 6. Claim number 1702 filed by PRPA is reduced and allowed as an unsecured non-priority class 7 claim under the Plan in the amount of \$218,752.00.
- 7. Claim numbers 1718 and 1731 filed by PRPA are disallowed in their entirety and expunged.
- 8. Claim number 1215 filed by Budapest is reduced and allowed as an unsecured non-priority class 7 claim under the Plan in the amount of \$139,281.00.
- 9. Claim number 1700 filed by Budapest is disallowed in its entirety and expunged.
- 10. Claim number 1196 filed by the ATAA is disallowed in its entirety and expunged.
- 11. Claim number 579 filed by Malev is disallowed in its entirety and expunged.
- 12. Claim number 1923 filed by ARE is reduced and allowed as an unsecured non-priority class 7 claim under the Plan in the amount of \$44,832.00.
- 13. Claim numbers 1795, 1190 and 1283 filed by Kent County are disallowed in their entirety and expunged.
- 14. Claim number 172 filed by Newspapers is disallowed in its entirety and expunged.
