MOTION TO CONVERT EVIDENTIARY HEARING SCHEDULED FOR NOVEMBER 16, 2006 TO A STATUS CONFERENCE

ATA Airlines, Inc. ("ATA"), one of the Reorganized Debtors², files this motion (this "Motion") and request that the evidentiary hearing initially scheduled for November 16, 2006 and regarding Reorganized Debtors' Objection To Certain Employee/Discrimination Claims (Claim Nos. 221, 222, 223, 229, 232 and 1391) [Docket # 4351] (the "Objection") be converted to a status conference.

- 1. This Court has jurisdiction over this Motion under 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2)(B). Venue of this proceeding and this Motion is properly in this district pursuant to 28 U.S.C. §§ 1408 and 1409. The statutory bases for the relief requested herein are 28 U.S.C. § 502 and Rule 3007 of the Bankruptcy Rules.
- 2. The Reorganized Debtors filed voluntary petitions for relief on October 26, 2004 (the "Petition Date"). The First Amended Joint Chapter 11 Plan For Reorganizing Debtors (the "Plan") was confirmed January 31, 2006, and became effective on February 28, 2006.

- 4. The above claimants (excluding Mr. Rochester Holmes) are hereafter referred to as the "Claimants" and the above claims (excluding claim 1391) are hereafter referred to as the "Claims".
- 5. On July 31, 2006, ATA filed the Objection on the grounds that the Claims are disputed and that ATA has no liability to the Claimants.
- 6. Because ATA and the Claimants are attempting to resolve this matter informally and so as to not cause ATA, the Claimants or this Court the undue costs of a lengthy evidentiary hearing, ATA, having received the consent of Claimants, respectfully requests that the evidentiary hearing initially scheduled to occur on November 16, 2006 be converted into a status conference at which the parties will agree on discovery and dispositive motion deadlines.

WHEREFORE, ATA respectfully requests the Court convert the evidentiary hearing initially scheduled for November 16, 2006 into a status conference and for all other just and proper relief.
