**ORDER EXTENDING TEMPORARY RESTRAINING
ORDER AND CONTINUING PRELIMINARY INJUNCTION HEARING**

This cause is before the Court on the Motion To Extend Temporary Restraining Order And Continue Preliminary Injunction Hearing (the "Motion") [docket #4634] filed by the Debtors on February 5, 2007. At the hearing previously scheduled for February 8, 2007 to address the application for preliminary injunction, the Court held a status hearing on the Motion. Walter K. Oetzell, Esq., of the firm Danning, Gill, Diamond & Kollitz, LLP participated on behalf of the City of Los Angeles and the Los Angeles World Airports and Department of Aviation (collectively, the "City"), and Terry E. Hall participated for ATA Airlines, Inc., the

Reorganized Debtor. The Court, having reviewed the Motion, and with the City consenting, GRANTS the request to extend the temporary restraining order (the "Temporary Restraining Order"). Accordingly,

1. The Temporary Restraining Order is extended nunc pro tunc from 5:00 p.m. on February 8, 2007 through and including the 8th day of March, 2007, unless disposed of at an earlier time following notice and hearing.

2. This matter is scheduled for a telephonic status hearing (the "Status Hearing"), and to resolve any procedural disputes, on the 16th day of February, 2007, at 11:30 a.m. EST. The dial-in telephone number for the parties to participate in the Status Hearing by conference call is 1-800-559-1261; passcode 6117474, followed by the pound ("#") key.

3. The City shall file a pleading as to any procedural objection it may have in this matter no later than February 12, 2007. Debtor shall respond to the City's procedural objection, if any, prior to the Status Hearing.

4. This matter is scheduled for further preliminary injunction hearing (the "Preliminary Injunction Hearing") on the 8th day of March, 2007 following the omnibus hearing at 9:30 a.m. EST, unless the City files a motion requesting an emergency hearing prior to the Status Hearing and setting forth its reasons for same, in which case, the Preliminary Injunction Hearing will instead be heard on the 23rd day of February, 2007, at 1:30 p.m. EST in the United States Bankruptcy Court for the Southern District of Indiana, Room 107, 121 W. Spring Street, New Albany, Indiana.
