## ORDER GRANTING VINCENT TRIBO'S MOTION FOR RELIEF FROM STAY

This matter is before the Court on the Motion For Relief From Stay (the "Motion") (docket #4610), filed by Vincent Tribo ("Mr. Tribo"), the Objection To Motion For Relief From Stay (the "Objection") (docket #4628) filed by ATA Airlines, Inc. ("ATA"), and the Amended Motion To Vacate Permanent Injunction (the "Motion to Vacate") (docket #4695) filed by Mr. Tribo. Due notice having been given and the Court having considered the Motion, Objection, and Motion to Vacate at the hearing on April 4, 2007, and being otherwise duly advised, now

The Debtors are the following entities: ATA Holdings Corp. (04-19866), ATA Airlines, Inc. (04-19868), Ambassadair Travel Club, Inc. (04-19869), ATA Leisure Corp. (04-19870), Amber Travel, Inc. (04-19871), American Trans Air Execujet, Inc. (04-19872), ATA Cargo, Inc. (04-19873), and Chicago Express Airlines, Inc. (04-19874).

GRANTS the Motion, it appearing to the Court that the request has been made for good cause. Accordingly,

## IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

- 1. The Motion is GRANTED subject to the limitations herein.
- 2. The injunction granted pursuant to the confirmation order entered in these cases [Docket No. 3657] ("Injunction") in the above captioned matter is modified to allow Mr. Tribo to proceed to prosecute his cause of action in the Circuit Court of Cook County, Illinois, County Department Law Division against ATA Airlines, Inc. ("ATA") (the "Illinois State Court Action").
- 3. To the extent Mr. Tribo is found to be entitled to any relief in the Illinois State Court Action, such relief shall be limited to compensatory damages payable from insurance and Mr. Tribo shall not seek any punitive damages in the Illinois State Court Action. Mr. Tribo shall collect all such compensatory sums that may become due to him as a result of the Illinois State Court Action only from the available insurance proceeds. Any monetary claims adjudged against ATA shall be collected only from the proceeds of any insurance and Mr. Tribo shall pursue no collection or other actions to collect any amounts from ATA, its affiliated debtors or any of their bankruptcy estates.
- 4. Nothing in this Order affects any and all defenses otherwise available to ATA or its insurance carrier in the Illinois State Court Action or in any other action related to the Illinois State Court Action.
