**RESPONSE OF MARION COUNTY TREASURER
TO C8 AIRLINES, INC.'S OBJECTION TO CLAIM No. 1469**

Comes now the Treasurer of Marion County, Indiana, by counsel, and for its Response to the Debtors' Objection to Claims states as follows:

1. The Marion County Treasurer timely filed his Proof of Claim for Indiana personal property taxes on January 6, 2005. This Claim is in the total amount of \$46,716.86.
2. In the paragraph 3 of the Objection, the Debtor asserts that this claim should be disallowed and expunged because "the claim asserts estimated taxes owing for nonspecific property without sufficient documentation....."
3. The Treasurer's priority unsecured claim is for business personal property taxes for which the Debtor filed self-assessment forms for Indiana property, which it owned on March 1, 2003, and March 1, 2004 (see attachments). As a result, this claim is properly due and owing and should thus be allowed as priority unsecured claim in this bankruptcy proceeding.

WHEREFORE, the Marion County Treasurer requests that its Priority Claim in the sum of \$46,716.86 as filed on January 6, 2005 in Case Number 04-19874 be allowed in full as outlined herein, that the Debtors' Objection to its claim be overruled, and for all other just and proper relief.
