**ORDER APPROVING STIPULATION REDUCING
ADMINISTRATIVE EXPENSE CLAIM OF SIGNATURE FLIGHT
SUPPORT CORPORATION AND AIRCRAFT SERVICE INTERNATIONAL, INC.**

This matter is before the Court on the Stipulation and Agreed Entry Reducing Administrative Expense Claim of Signature Flight Support Corporation and Aircraft Service International, Inc. (the "Stipulation"), filed jointly by plaintiff C8 Airlines, Inc. ("C8") and defendants Signature Flight Support Corporation ("Signature") and Aircraft Service International, Inc. ("ASII"). In the Stipulation, C8, Signature and ASII seek entry of an Order reducing the administrative expense claim of Signature and ASII from \$32,077.87 to \$17,077.87. This Court,
