ORDER APPROVING STIPULATION RESOLVING CLAIMS
(MBNA (Transferred to eCAST) Claim Nos. 2142, 2143, and 2144)²

This matter is before the Court upon the Stipulation To Resolve Claims (MBNA (Transferred to eCAST) Claim Nos. 2142, 2143, and 2144) (docket #4933) (the "Stipulation")³ filed by Debtor and eCAST Settlement Corporation ("Claimant"). Debtor and Claimant filed the Stipulation evidencing their agreement that Claim No. 2143 should be reduced and allowed as a

timely filed general unsecured claim in the reduced aggregate amount of \$2,500.00, and Claim No. 2142 and Claim No. 2144 should be disallowed and expunged. The Court, having reviewed the Stipulation, and being otherwise duly advised, now APPROVES the Stipulation, it appearing to the Court that the request has been made for good cause. Accordingly,

IT IS HEREBY ORDERED that:

1. The Stipulation is approved.
2. Claim Nos. 2142 and 2144 are disallowed and expunged.
3. Claim 2143 is allowed as a general unsecured claim against the Debtor's

estate in the amount of \$2,500.00.
