This matter is before the Court on the Agreed Entry Resolving Claims And Adversary Proceeding Of Goodrich Corporation And ATA Airlines, Inc. (Claim Nos. 69 and 1354) (the "Agreed Entry") (docket #4930) filed by ATA Airlines, Inc. ("ATA"), one of the above-captioned debtors and debtors-in-possession, and Goodrich Corporation ("Goodrich").

ATA and Goodrich filed the Agreed Entry evidencing their agreement (i) to allow the Claims<sup>2</sup> in a zero dollar amount against the Reorganizing Debtors' estates to be paid pursuant to the confirmed plan, (ii) to resolve the Objection and Response, and (iii) to file an agreed entry dismissing the Adversary Proceeding with prejudice. The Court, having reviewed the Agreed Entry, and being otherwise duly advised, now APPROVES the Agreed Entry, it appearing to the Court that the request has been made for good cause. Accordingly,

IT IS HEREBY ORDERED that:

- a. The Agreed Entry is approved.
