

This notice shall not affect any right either ASI and SFS otherwise may have (a) to object and not submit to the jurisdiction of the Bankruptcy Court for any particular purpose, matter or proceeding, (b) to have final orders in non-core matters entered only after a de novo review by a District Judge, (c) to trial by jury in any proceeding arising in or related to this case, or (d) to request that the District Court withdraw the reference in any matter or proceeding subject to mandatory or discretionary withdrawal, all of which rights are hereby retained and reserved. Further, ASI and SFS retain and reserve any and all other rights, claims, actions, setoffs or recoupments to which they are or may become entitled, in law or in equity, with respect to the debtors or their assets in the above-referenced case, and retain and reserve any and all rights, claims, actions and remedies they have or may have with respect to all entities other than the debtors.

4. Pursuant to Rule B-2018-1(b) of the Local Rules, this notice of intervention shall be deemed granted without separate order of this Court (subject to possible revocation in accordance with the Local Rules), and shall be treated as an appearance for purposes of Fed. R. Bankr. P 9010(b).


