ORDER SHORTENING NOTICE

This matter is before the Court upon Debtors' Motion To Shorten Notice On Debtors' Motion For Entry Of An Order Authorizing The Debtors To Reject Certain Leased Aircraft Equipment filed on December 8, 2004 (the "Motion")².
