**ORDER GRANTING REQUEST PURSUANT TO LOCAL RULE B-9006-1 FOR
EXPEDITED HEARING ON DEBTOR'S MOTION FOR AN ORDER AUTHORIZING,
BUT NOT DIRECTING, THE DEBTOR TO PAY CERTAIN
EMPLOYEE BENEFIT PLAN PREMIUMS**

This Court has considered the Request Pursuant to Local Rule B-9006-1 for Expedited Hearing on Debtor's Motion for Expedited Hearing on Debtor's Motion for an Order Authorizing, but not Directing, the Debtor to Pay Certain Employee Benefit Insurance Premiums (the "9006(c) Request") filed by ATA Airlines, Inc. (the "Debtor"). The 9006(c) Request requests an order scheduling the Expedited Motion (as defined in the 9006(c) Requests) for hearing at the First Day Hearing Date (as defined in the 9006(c) Request). The Court finds that

(i) it has jurisdiction over the matters raised in the 9006(c) Request under 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding under 28 U.S.C. § 157(b)(2); (iii) the relief requested in the 9006(c) Request is in the best interests of the Debtor, its estate, and its creditors; (iv) proper and adequate notice of the 9006(c) Request and the hearing thereon has been given and that no other or further notice is necessary; and (v) on the record herein after due deliberation thereon, good and sufficient cause exists for the granting of the relief as set forth herein.

Therefore,

IT IS HEREBY ORDERED THAT:

1. The 9006(c) Request is GRANTED.
2. The Expedited Motion will be heard on April 11, 2008 at 11:30 a.m. EDT at the United States Bankruptcy Court for the Southern District of Indiana, United States Courthouse, Room 310, 46 E. Ohio Street, Indianapolis, Indiana.
