SUBJECT: Logistical Arrangements for Hearing in *In re ATA Airlines, Inc.* Case No. 08-03675-BHL-11

1. The faculty and students of the Indiana University Maurer School of Law welcome you to our School. Please let anyone know if we can do anything to support you during your visit.
2. General driving directions have been posted on the Debtor website and are available at <http://www.law.indiana.edu/visit/index.shtml>
3. Specific directions from the Indianapolis International Airport are attached hereto as Enclosure 1. Note that the Indianapolis Airport terminal has moved in the last few months to a different location at the same airport. Mapquest and Google direction sites have not been fully updated.
4. Ample parking is available within a few yards of the School of Law in the Henderson Parking Garage. A map of the parking garage location and the short walking route to the School of Law is attached hereto as Enclosure 2.
5. You should enter the School of Law by the side (south) door and take the short stairway down to the first floor. The Moot Court Room is the second room on your right. Students will be standing by beginning at 2:30 to direct you.
6. You are welcome to use the School of Law's wireless computer network. You will need to do a very short guest registration procedure. Our IT personnel will be standing by to assist.

ENCLOSURE 1

Directions from the Indianapolis International Airport to the Indiana University Maurer School of Law

1. Depart Indianapolis International Airport. Follow signs to I-70 East. Enter I-70 East at Exit 68.
2. Follow I-70 approximately one mile to junction with I-465 South. Take first ramp on the right to I-465 South.
3. Follow I-465 for 6 miles to Exit 4. Take ramp on the right to IN-37 South.
4. Follow IN-37 South for 39 miles to Walnut Street/College Avenue Exit. Take ramp on the right to North Walnut Street.
5. Follow North Walnut Street which becomes North College Avenue for 5 miles to West Third Street. West Third Street is the second cross-street after the Courthouse Square. Turn Left on West Third Street. Stay in the middle lane.
6. Follow West Third Street for 0.4 miles. At the fourth stop light, Third Street is forced to the right and becomes Atwater Avenue. After bearing right onto Atwater, stay in left lane and turn left immediately onto Indiana Avenue.
7. On Indiana Avenue, immediately move to the right lane and enter the Henderson Parking Garage. The Parking Garage is within 100 yards of the School of Law.
8. See attached map for walking route to the School of Law.
9. Enter the School of Law by the side (South) single-door entrance. Take steps down to first floor. Students will be in the hallway to direct you into the Moot Court Room where the hearing will be held.
10. Welcome to the Indiana University Maurer School of Law.

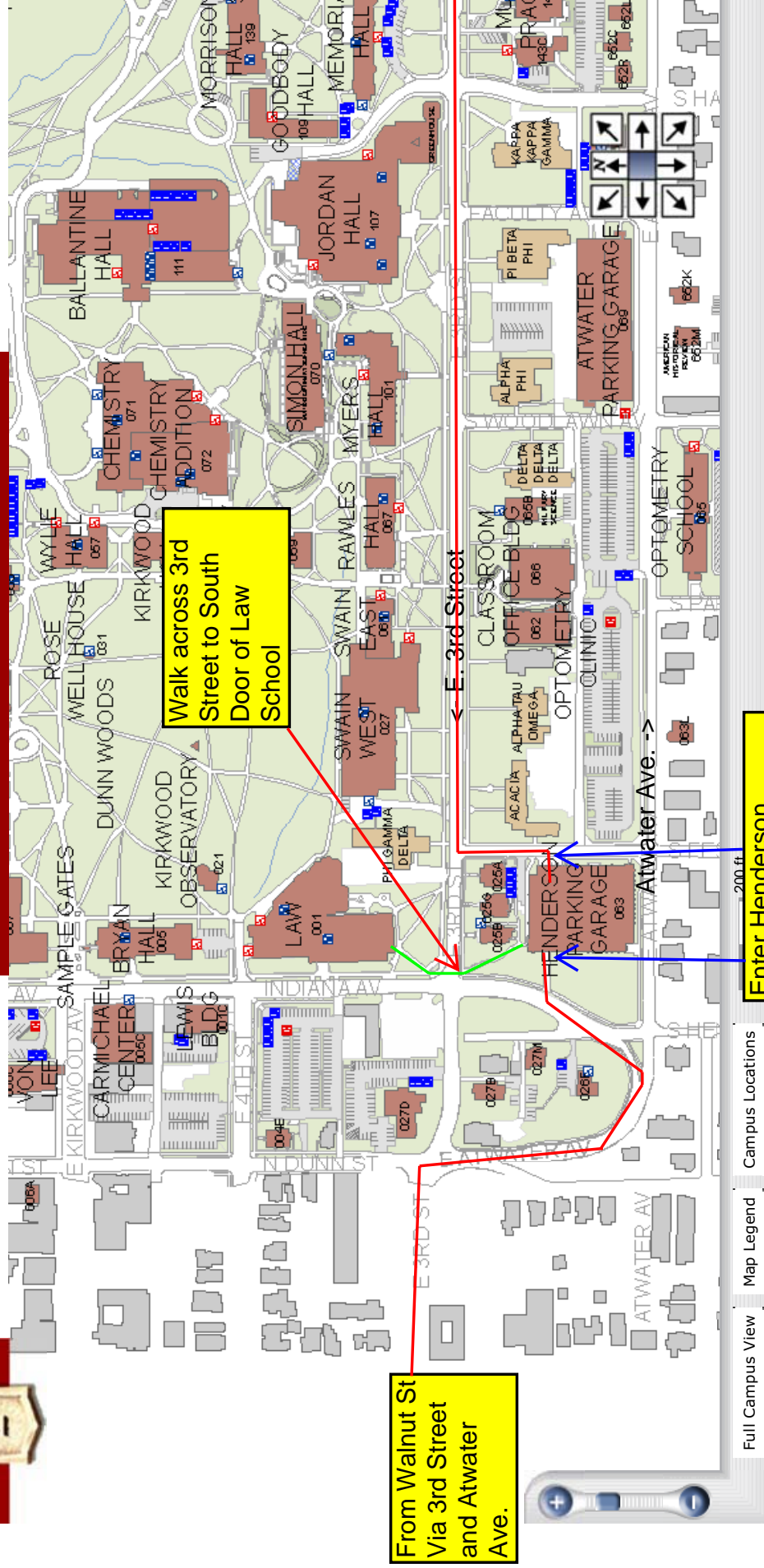
