**ORDER GRANTING MOTION FOR ENTRY OF AN ORDER AUTHORIZING  
THE DEBTOR TO SELL DOMAIN NAMES FREE AND CLEAR OF LIENS AND  
ENCUMBRANCES PURSUANT TO 11 U.S.C § 363 AND FED. R. BANKR. P. 2002(c)  
AND 6004 AND PAY THE COSTS AND EXPENSES OF SALE**

This matter came before the Court upon the Motion for Entry of an Order Authorizing the Debtor to Sell Domain Names Free and Clear of Liens and Encumbrances Pursuant to 11 U.S.C § 363 and Fed. R. Bankr. P. 2002(c) and 6004 and Pay the Costs and Expenses of Sale (the “Motion”) filed by ATA Airlines, Inc. (the “Debtor”). The Court finds that it has jurisdiction over the matters raised in the Motion pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) the relief requested in the Motion is in the best interests of the Debtor, its estate, and its creditors; (iv) proper and adequate notice of the Motion has been given and no other or further notice is necessary; and (v) upon the record herein

after due deliberation thereon, good and sufficient cause exists for the granting of the relief as set forth herein.

Therefore,

IT IS HEREBY ORDERED THAT:

1. The Motion is granted in all respects.
2. The Debtor is authorized to sell the Domain Names<sup>1</sup> at public auctions, free and clear of liens.
3. Auctions of the Domain Names (the "Auctions") shall be held, at the Debtor's discretion, at any time after the entry of this Order. The Auctions shall be conducted on the website [www.godaddy.com](http://www.godaddy.com), which shall be open to all persons interested in purchasing the Domain Names.
4. The Debtor is authorized to make the following determinations as to each individual Auction: the reserve sale price, the length of the auction, the premium pricing options to employ, and whether to re-list the Domain Name with different auction options if the Domain Name is not purchased.
5. The Debtor is authorized to pay the costs and expenses associated with the auctions.
6. The Debtor shall file a report of sale within 7 days of the completion of the auctions and shall transmit a copy of the report to the United States Trustee, counsel for JPMorgan and counsel for the Committee. In addition, the Debtor shall prepare and file with the report an affidavit listing the commission and costs paid by the Debtor. Unless a party in interest objects to the report and affidavit within 5 days from the filing of the report and affidavit, no

further hearing is required to approve the results of the Auctions or to approve the payment to GoDaddy of its commissions and fees.
