**NOTICE OF CLAIM OBJECTION AND RESPONSE PROCEDURES**

On January \_\_, 2009, the Debtor filed its Omnibus Objection to Unsupported Customer Claims (the “Omnibus Objection”). A copy of the Omnibus Objection is included with this Notice. Please carefully review the Omnibus Objection, including Exhibit A thereto. If you filed a proof of claim in the ATA Airlines bankruptcy case, and your claim is listed on Exhibit A of the Omnibus Objection, then your claim has been objected to by the Debtor.

If your claim has been objected to, you must follow the procedures established in the attached Order Granting the Motion to Establish Procedures to Gather Supporting Information for Customer Claims Pursuant to 11 U.S.C. §§ 105(a) and 507(a)(7) (the “Order”).

**PURSUANT TO THE ORDER, YOU DO NOT NEED TO FILE A RESPONSE TO THE OMNIBUS OBJECTION WITH THE BANKRUPTCY COURT AT THIS TIME. YOU MUST, HOWEVER, COMPLETE AND RETURN THE ATTACHED CUSTOMER CLAIM INFORMATION FORM (“CCI FORM”) NO LATER THAN FEBRUARY 13, 2009 (THE “DEADLINE”). FAILURE TO COMPLETE AND RETURN A CCI FORM BY THE DEADLINE WILL RESULT IN THE DISALLOWANCE OF YOUR CLAIM.**

The CCI Form must be returned to the Debtor (i) by email to ATA@haynesboone.com; (ii) by fax to 713-236-5490, Attn: Kourtney Lyda, Esq.; or (iii) by mail to 1 Houston Center, 1221 McKinney, Ste 2100, Houston, Texas 77010, Attn: Kourtney Lyda, Esq.

The Court will conduct an initial hearing (the “Initial Hearing”) on the Omnibus Objection on February \_\_, 2009. **If you timely submit a CCI Form, it is not necessary for you to appear at the Initial Hearing.** At the Initial Hearing, the Debtor will advise the Court who failed to timely submit a CCI Form and who timely submitted a CCI Form. If you failed to submit a CCI Form by the Deadline, the Debtor will, at the Initial Hearing, seek entry of an order disallowing or recharacterizing your claim consistent with the proposed disposition of your claim in Exhibit A to the Omnibus Objection. If you submitted a CCI Form by the Deadline, you will be provided with further notice after the Initial Hearing which will inform you whether (i) the CCI Form did not contain all of the information required and you are now required to file a formal response to the Omnibus Objection and appear at a future hearing to determine whether your claim will be allowed; or (ii) your claim is being allowed, and in what amount.
