

#### Items to be completed in Proof of Claim form

#### Court, Name of Debtor, and Case Number:

Fill in the debtor's full name, and the bankruptcy case number. If the creditor received a notice of the case from the bankruptcy court, all of this information is at the top of the notice.

**2. Basis for Claim:**

**DEFINITIONS**

**Debtor**

A debtor is the person, corporation, or other entity that has filed a bankruptcy case.

**Creditor**

A creditor is a person, corporation, or other entity to whom debtor owes a debt that was incurred before the date of the bankruptcy filing. See 11 U.S.C. § 101(10).

**Claim**

A claim is the creditor's right to receive payment for a debt owed by the debtor on the date of the bankruptcy filing. See 11 U.S.C. § 101(5). A claim may be secured or unsecured.

**Proof of Claim**

A proof of claim is a form used by the creditor to indicate the amount of the debt owed by the debtor on the date of the bankruptcy filing. The creditor must file the form with the Debtors' claims agent, BMC Group, Inc., at the applicable following address:

**Secured Claim Under 11 U.S.C. § 506(a)**

A secured claim is one backed by a lien on property of the debtor. The claim is secured so long as the creditor has the right to be paid from the property prior to other creditors. The amount of the secured claim cannot exceed the value of the property. Any amount owed to the creditor in excess of the value of the property is an unsecured claim.

Examples of liens on property include a mortgage on real estate or a security's interest in a car. A lien may be voluntarily granted by a debtor or may be obtained through a court proceeding. In some states, a court judgment is a lien. A claim also may be secured if the creditor owes the debtor money (has a right to setoff).

**Unsecured Claim**

An unsecured claim is one that does not meet the requirements of a secured claim. A claim may be partly unsecured if the amount of the claim exceeds the value of the property on which the creditor has a lien.

**Claim Entitled to Priority Under 11 U.S.C. § 507(a)**

Priority claims are certain categories of unsecured claims that are paid from the available money or property in a bankruptcy case before other unsecured claims.

**Administrative Claim**

An administrative claim is a claim of the type described in sections 503 and 507 of title 11 of the United States Code. Among other things, these sections provide that certain types of claims are entitled to administrative expense priority, including, without limitation: (i) the action, necessary costs and expenses of preserving the estate, including wages, salaries, or commissions for services rendered after the commencement of the bankruptcy case; (ii) certain taxes and penalties related thereto; (iii) compensation and reimbursement of certain officers; (iv) the actual, necessary expenses incurred by (a) certain creditors, (b) a creditor, an indenture trustee, an equity security holder, or a committee representing any such entities, in making a substantial contribution to a debtor's chapter 11 case, (c) a custodian, and (v) compensation for services rendered by an indenture trustee. Claims alleged to be entitled to an administrative expense pursuant to 11 U.S.C. § 503(b)(9) should be listed in item 6 of the form, but not in item 1a.

**Administrative Claim Under 11 U.S.C. § 503(b)(9)**

Claims that are based upon facts or circumstances arising or occurring after the date of the Bankruptcy filing and that qualify as an administrative expense under section 503(b)(9) (excluding 503(b)(9) of the Bankruptcy Code).

**Redacted**

A document has been redacted when the person filing it has masked, edited out, or otherwise deleted, certain information. A creditor must show only the last four digits of any social-security, individual's tax-identification, or financial-account number, only the initials of a minor's name, and only the year of any person's date of birth. If the claim is based on the delivery of health care goods or services, limit the disclosure of the goods or services so as to avoid embarrassment or the disclosure of confidential health care information.

**Evidence of Perfection**

Evidence of perfection may include a mortgage, lien, certificate of title, financing statement, or other document showing that the lien has been filed or recorded.

**INFORMATION**

**Acknowledgment of Filing of Claim**

To receive acknowledgment of your filing, you may either enclose a stamped self-addressed envelope and a copy of this proof of claim or you may access the court's PACER system ([www.pacer.psc.uscourts.gov](http://www.pacer.psc.uscourts.gov)) for a small fee to view your filed proof of claim.

**Offers to Purchase a Claim**

Certain entities are in the business of purchasing claims for an amount less than the face value of the claims. One or more of these entities may contact the creditor and offer to purchase the claim. Some of the written communications from these entities may easily be confused with official court documentation or communications from the debtor. These entities do not represent the bankruptcy court or the debtor. The creditor has no obligation to sell its claim. However, if the creditor decides to sell its claim, any transfer of such claim is subject to FRBP 3001(c), any applicable provisions of the Bankruptcy Code (11 U.S.C. § 101 *et seq.*), and any applicable orders of the bankruptcy court.

ATTACHMENT TO PROOF OF CLAIM OF  
EMPLOYERS INSURANCE COMPANY OF WAUSAU

The partially unliquidated and contingent secured and general unsecured prepetition claim (the "Claim") of Employers Insurance Company of Wausau, on behalf of itself and its affiliates and subsidiaries (collectively, "Wausau"), arises from insurance policies and related agreements (collectively, the "Policies") pursuant to which AgFeed USA, LLC and certain related entities (collectively, the "Debtor") is liable to pay premiums and related charges.

The Policies provide, subject to their terms, conditions, limitations, and exclusions, certain insurance coverage for the benefit of the Debtor, including, without limitation, workers' compensation coverage for the period from approximately March 2009 until March 2013. Certain Policies include provisions whereby premiums are subject to future audit, or the Debtor may be obligated to pay amounts within the deductible layer of the applicable policy. Wausau's prepetition claim is liquidated in the amount of \$620,718.00, for amounts due to Wausau on account of, among other things, premium obligations and loss billings. The remainder of Wausau's prepetition claim is unliquidated and contingent because, under the provisions of the Policies, additional premiums and related charges may be due and owing to Wausau.

Wausau's claims are secured by a right of setoff and/or recoupment in any credits or refunds that may be owing now or in the future to the Debtor. Wausau hereby files a protective claim for reimbursement of any of the Debtor's indemnification obligations that may be covered under the terms of the Policies, should they exist, and for damages arising from any breach by the Debtor of its obligations under the Policies.

Wausau expressly reserves all of its rights under the Policies, the Bankruptcy Code and applicable law, and nothing herein shall affect Wausau's rights under the same. Further, Wausau expressly reserves all of its rights against all non-debtor parties who may be or may become liable under or with respect to the Policies, including, without limitation, claims against non-debtor parties for misrepresentation in connection with payments, releases, or other transfers made or given by Wausau. Given the nature of the Policies and the Debtor's obligations under them, Wausau further reserves the right to supplement or amend its claims as circumstances warrant. 




