KEITH A. MAIB REQUEST FOR ALLOWANCE OF ADMINISTRATIVE CLAIM

2. By this Administrative Claim Request, I make a claim to all amounts due and owing to me or that become due and owing to me arising from my service as an officer and/or director of the Debtors.

3. By virtue of the my role as an officer and/or director of the Debtors, the Debtors were, and are indebted and/or liable to me for the indemnification and advancement obligations provided in, without limitation, the *Amended and Restated Articles of Incorporation of Wallace*



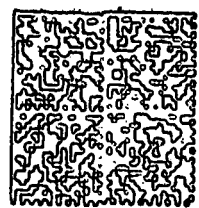
