**CERTIFICATION OF NO OBJECTION REGARDING EIGHTH MONTHLY
APPLICATION OF GREENBERG TRAURIG, LLP FOR COMPENSATION AND
REIMBURSEMENT OF EXPENSES AS CO-COUNSEL TO THE OFFICIAL
COMMITTEE OF UNSECURED CREDITORS FOR THE PERIOD FROM FEBRUARY
1, 2014 THROUGH AND INCLUDING FEBRUARY 28, 2014 [RE DOCKET NO. 1018]**

The undersigned counsel to the Official Committee of Unsecured Creditors (the “Committee”), in the above captioned cases, hereby certify the following:

1. On August 21, 2013, the U.S. Bankruptcy Court for the District of Delaware (the “Court”) entered the *Order Authorizing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals* [Docket No. 176] (the “Interim Compensation Order”).

2. In accordance with the Interim Compensation Order, on April 11, 2014, Greenberg Traurig, LLP (“Greenberg”) filed its *Eighth Monthly Application* (the “Application”) *for Compensation and Reimbursement of Expenses as Co-Counsel to the Official Committee of Unsecured Creditors for the Period from February 1, 2014 through and including February 28, 2014* [Docket No. 1018] with the United States Bankruptcy Court for the District of Delaware.

3. Pursuant to the Notice of Application, objections were to be filed and served no later than May 1, 2014 at 4:00 p.m. No objections or responses have been received or filed on the docket as of May 6, 2014.

4. Pursuant to the Interim Compensation Order and the Application, the Debtors are authorized to pay Greenberg for 80% fees in the amount of \$20,920.00 and 100% expenses in the amount of \$558.80 as follows: (a) \$15,040.00 (fees) and \$401.72 (expenses) from AgFeed Industries, Inc. and (b) \$5,880.00 (fees) and \$157.08 (expenses) from AgFeed USA, LLC. These fees represent the Actual Interim Payment as defined in the Interim Compensation Order.
