**AMENDED EIGHTH MONTHLY APPLICATION OF FOLEY & LARDNER LLP AS
SPECIAL COUNSEL TO THE DEBTORS, FOR ALLOWANCE OF COMPENSATION
FOR SERVICES RENDERED AND FOR REIMBURSEMENT OF EXPENSES FOR THE
PERIOD FROM MARCH 1, 2014 THROUGH MARCH 31, 2014**

Pursuant to sections 330 and 331 of title 11 of the United States Code (the “Bankruptcy Code”), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and the Court’s Order Authorizing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals [Docket No. 176] (the “Interim Compensation Order”), Foley & Lardner LLP (“Foley”) hereby files this Amended Eighth Monthly Application for Allowance of Compensation for Services Rendered and for Reimbursement of Expenses for the Period From March 1, 2014 through March 31, 2014 (the “Application”). By this Application, Foley seeks approval of compensation in the amount of \$42,350.40 as compensation for services rendered and \$1,125.36 in reimbursement of actual and necessary expenses, for a total of \$43,475.76, during the period of March 1, 2014 through March 31, 2014 (the “Compensation Period”). In support of this Application, Foley respectfully represents as follows:

Background

1. On July 15, 2013 (the “Petition Date”), the above-captioned Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code.

2. On July 31, 2013, the Debtors filed their application for an order authorizing the retention of Foley as special counsel to the Debtors under section 327(e) of the Bankruptcy Code, *nunc pro tunc* to the Petition Date (the “Retention Application”) [Docket No. 91].

3. On August 28, 2013, the Court entered an order approving the Retention Application effective as of the Petition Date (the “Retention Order”) [Docket No. 241].

Compensation Paid and Its Source

4. All services for which compensation is requested by Foley were performed for or on behalf of the Debtors.

5. As disclosed in the Retention Application, Foley holds a pre-petition retainer to be applied against its fees incurred during the Chapter 11 Cases as such fees are approved until the retainer is exhausted. Foley has otherwise received no payment and no promises for payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with the matters covered by this Application. There is no agreement or understanding between Foley and any other person other than the directors of Foley for the sharing of compensation to be received for services rendered in these cases.

Foley’s Fee and Expense Detail

6. Foley incurred fees for professional services rendered to the Debtors during the Compensation Period in the gross amount of \$52,938.00. However, pursuant to an agreement with the Official Committee of Equity Security Holders, Foley has agreed to reduce its fees by 20%, which brings Foley’s fees for the Compensation period to \$42,350.40. Foley’s fee detail for the Compensation Period is attached hereto as Exhibit A. This detail contains daily time logs

describing the time spent by each professional for this period. To the best of Foley's knowledge, this Application complies with sections 330 and 331 of the Bankruptcy Code, the Bankruptcy Rules, the Guidelines adopted by the Office of the United States Trustee, Del. Bankr. L.R. 2016-2, and the Interim Compensation Order.

7. Foley also incurred actual and necessary expenses in the amount of \$1,125.36 during the Compensation Period. Foley's expense detail for the Compensation Period is attached to this Application as Exhibit B.

8. In accordance with the Interim Compensation Order, Foley requests that, upon the expiration of the objection deadline with respect to this Application, and the filing of a certificate of no objection, the Debtors be authorized to pay Foley an amount equal to 80 percent of the fees and 100 percent of the expenses requested in this Application, to the extent that any such amounts are owed after application of the retainer.

Summary of Services by Project Category

9. The services Foley performed for the Debtors during the Compensation Period can be grouped into the categories set forth below. These categories are generally described below, with a more detailed identification of the actual services provided set forth on the attached Exhibit A.

A. Fee/Employment Applications

Gross Fees: \$11,905.50 Hours: 19.5

This category relates to services performed by Foley professionals in connection with the retention and compensation of Foley as special counsel to the Debtors in these chapter 11 cases, including work on Foley's monthly and interim fee applications, work in response to objections to such applications, work in connection with attendance at hearings on Foley's interim fee applications, and other matters.

B. Board of Directors Meetings

Gross Fees: \$1,114.00 Hours: 1.7

This category relates to work by Foley professionals in connection with the Board of Directors meetings of AgFeed Industries, Inc., including preparation for, attendance at, and follow-up on such Board of Directors meetings.

C. D&O Coverage Issues

Gross Fees: \$12,762.00 Hours: 17.4

This category relates to services performed by Foley professionals in connection with the Debtors' directors' and officers' liability insurance coverage, including services aimed at securing coverage of certain claims.

D. AF Sellco LLC Claim

Gross Fees: \$19,314.50 Hours: 28.6

This category relates to services performed by Foley professionals in connection with the Debtor's claim against AF Sellco LLC.

E. HR Issues

Gross Fees: \$193.50 Hours: 0.3

This category relates to work performed by Foley professionals relating to human resources issues, including various employee retention, termination, and compensation issues.

F. Sale of Assets – Documentation & Negotiation

Gross Fees: \$144.00 Hours: 0.2

This category relates to counseling Foley provided to the Debtors with respect to the sale of certain China-based assets of AgFeed Industries, Inc. and/or its subsidiaries.

G. SEC Filings

Gross Fees: \$6,525.00 Hours: 9.6

This category relates to work performed by Foley professionals to assist the Debtors in complying with their SEC filing requirements, including services with respect to the preparation and filing of the Debtors' forms 8-K.

H. SEC Investigation

Gross Fees: \$979.50 Hours: 1.2

This category relates to work performed by Foley in connection with the investigation of the Debtors by the SEC.

Certification

10. In accordance with Local Rule 2016-2(f), the undersigned has reviewed the requirements of Local Rule 2016-2 and certifies to the best of his information, knowledge and belief that this Application complies with Local Rule 2016-2 except as otherwise stated herein.

WHEREFORE, Foley respectfully requests that the Court (i) approve this Application; (ii) authorize Foley to draw down upon its retainer all amounts due and owing in accordance with the Interim Compensation Order, (iii) authorize the Debtors to remit to Foley any remaining amounts due and owing in accordance with the Interim Compensation Order; and (iv) grant such other and further relief as may be appropriate.
