**SUPPLEMENTAL DECLARATION OF GEORGIOS CHRISTOFOROU  
IN SUPPORT OF APPLICATION TO EMPLOY  
AND RETAIN U TURN BUSINESS RECOVERY CONSULTANTS LTD.  
AS DEBTOR’S FINANCIAL ADVISOR IN THE COUNTRY OF GREECE**

I, Georgios Christoforou, being duly sworn, state the following under penalty of perjury:

1. I am the founder and a principal of U Turn Business Recovery Consultants Ltd. (“U Turn”), a financial advisory firm, with offices located in Athens, Greece, registered offices in Cyprus and operations in Cyprus, Greece and the region.

2.
