ORDER REFERRING MATTERS TO MEDIATION AND APPOINTING MEDIATOR

The Court, having been advised by counsel for Adam Meislik (the “Liquidating Trustee”), as Trustee of the Airfasttickets, Inc. Liquidating Trust, that the Liquidating Trustee and counsel for Frank Ferro, Nikolaos Koklonis and Eleni Vareli (together with the Liquidating Trust, collectively, the “Parties”) have agreed to mediate certain disputes between them arising (1) in the above-captioned bankruptcy case, (2) in the adversary proceeding entitled *Meislik v.*

Ferro, et al., Adv. Proc. No. 16-01207 (SHL) (the “Ferro Adversary”), and (3) in the adversary proceeding entitled *Airfasttickets, Inc. v. Citibank, N.A., et al.*, Adv. Proc. No. 16-01040 (SHL) (the “Citibank Adversary”); and after due deliberation and sufficient cause appearing therefor; it is hereby

ORDERED that the issues raised in and related to (1) the Ferro Adversary; (2) the Citibank Adversary; (3) the *Objection to Proof of Claim Filed by Nikolaos Koklonis* (the “Claim Objection”) [Docket No. 216] filed by Airfasttickets, Inc. (the “Debtor”); (4) the *Motion for Payment of Administrative Expense* (the “Koklonis Administrative Claim Motion”) [Docket No. 261] filed by Mr. Koklonis; and (5) all other claims asserted by Mr. Koklonis shall be and hereby are referred to mediation; and it is further

ORDERED that Jed D. Melnick, Esq., of JAMS, shall be and hereby is appointed as mediator; and it is further

ORDERED that, following the conclusion of the mediation, the Liquidating Trustee shall file a paper notifying the Court of the results of the mediation; and it is further

ORDERED that all pending hearings in the Ferro Adversary and the Citibank Adversary, and relating to the Claim Objection and the Koklonis Administrative Claim Motion shall be and hereby are ~~adjourned~~ *stayed* ~~for a period of approximately 90 days~~ *for the duration of the mediation*; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from or related to this Order.
