General Disclaimer

The Debtor's court-appointed receiver (the "Receiver"), with the assistance of the Debtor's proposed financial advisor, have prepared the Debtor's Schedules of Assets and Liabilities and the Statement of Financial Affairs (the "Schedules") based on the information reflected in the Debtor's current books and records. However, the Debtor's current books and records have not been audited as of the date of these Schedules, and cannot warrant the absolute accuracy of these documents. The Receiver has made a diligent effort to complete these documents accurately and completely. To the extent additional information becomes available, the Debtor will amend and supplement the Schedules.

Schedule B Disclaimer

Unless otherwise noted, all of the amounts listed on Schedule B represent the value of the Debtor's assets as reflected in the Debtor's books and records. The Receiver performed no independent review of the value of these assets. The actual value of the assets listed may differ significantly from the amounts reflected in the Debtor's books and records. The Debtor is currently investigating the net realizable or market value of many of these assets. Indeed, the Debtor's accounts receivable and the amount purportedly due are currently being investigated by the Debtor and are allegedly due from fictitious entities.
