NOTICE OF REVISED ORDER GRANTING MOTION OF THE LIQUIDATING TRUST OF AIRFASTTICKETS, INC. UNDER SECTION 105(A) FOR AN ORDER ESTABLISHING PROCEDURES FOR THE EXCHANGE OF INFORMATION AND REVIEW OF INTELLECTUAL PROPERTY, SOFTWARE AND RELATED ASSETS OF TRAVANA, INC. AND FAREPORTAL, INC. ON A CONFIDENTIAL BASIS, IN CONNECTION WITH CONTESTED MATTER

PLEASE TAKE NOTICE that on February 18, 2020, the Liquidating Trust of Airfasttickets, Inc. (the “AFT Trust”), through Adam Meislik, the duly appointed trustee of the Liquidating Trust (the “AFT Trustee”), by its undersigned counsel, filed the *Motion of the Liquidating Trust of Airfasttickets, Inc. Under Section 105(a) for an Order Establishing Procedures for the Exchange of Information and Review of Intellectual Property, Software and Related Assets of Travana, Inc. and Fareportal, Inc. on a Confidential Basis, in Connection with Contested Matter* (the “Motion”).¹ A proposed form of order (the “Original Order”) was attached to the Motion as Exhibit A. The deadline to object to the relief sought in the Motion was February 25, 2020 at 4:00 p.m. (prevailing Eastern Time) (the “Objection Deadline”).

¹ Capitalized terms not defined herein shall have the meanings ascribed to them in the Motion.

PLEASE TAKE FURTHER NOTICE that prior to the Objection Deadline, the AFT Trust received an informal response from Fareportal, Inc. (“Fareportal”). Fareportal provided comments to the Original Order to which the AFT Trust has agreed. A copy of a revised proposed form of order (the “Revised Order”) incorporating Fareportal’s comments is attached hereto as **Exhibit A**. For the convenience of the Court and all parties in interests, attached hereto as **Exhibit B** is a redline comparison of the Revised Order against the Original Order.

PLEASE TAKE NOTICE that the AFT Trust received no other objections or comments to the Motion or Original Order prior to the Objection Deadline. The AFT Trust was contacted by counsel for the Chen Parties on Friday, February 28, 2020, after the Objection Deadline.
